Notes on how to complete the Intrastat Continuation Sheet. Detailed advice on completion of the Header Sheet and on Intrastat in general can be found in the Intrastat General Guide Notice 60 or on our website www.uktradeinfo.com

Period (mm/yy)	The period is the month and year to which the declaration refers, for example use 11/01 for November 2001.
Sheet number	Show the order of the sheets for example use 0306 for continuation sheet three for a total of six.
Number of lines	If you are declaring more than 176 lines, please submit them in batches containing no more than 14 continuation sheets to each C1500 or C1501 header sheet.

Have you thought about submitting your Intrastat data via the internet?

1. It's easier and quicker, your data is validated online. It's worry-free. Send your data continuously through the month (little and often).
